What do I need to bring with me or prepare for?

- ✓ Complete an application form;
- Letter confirming employment for current employer;
- ✓ Contract of sale and purchase agreement;
- ✓ Letter of acceptance from vendor;
- ✓ Evidence of 25% equity contribution;
- Superannuation ID and copy of statements for the last 12 months for savings, loans and credit card facilities with other financial service providers;
- ✓ Copy of driver's license;
- Salary Deduction Authority or standing order for loan repayment;
- Evidence of other income;
- ✓ Mandatory BSP Account;

- ✓ Salary to be redirected to BSP account;
- Properties to be insured for the loan term. Inclusive of cyclone cover and supported by engineers certificate;
- Confirmation of ownership of major assets advised eg; copy of state lease, copy of vehicle registration, must be provided with application.

If constructing new property, you will be required to submit the following:

- ✔ Building plan;
- ✓ Land receipts (government or custom);
- Copy of the land title;
- ✔ Builders contract or quote;
- ✔ Property valuation by BSP's panel of valuers.
